Late Payment Penalty:

If a monthly installment is not paid within a **7-day grace period** after the due date, a **daily penalty of 2%** of the overdue amount **will be deducted** from the refundable deposit **until the overdue balance is cleared**.

If the overdue payments continue beyond a reasonable period, **FlexyRent reserves the right to take legal action**, and further deductions may be made from the deposit as necessary to recover the defaulted amount.



4.Obligations of the Borrower

The Borrower agrees to:

- Repay all monthly installments on time.
- Notify FlexyRent immediately of any changes in employment, income, or address.
- Maintain an active and reachable guarantor for the duration of the loan period.
